## **DOCUMENT REQUIREMENTS FOR PLACEMENT INTO YEAR 7 2022**

All applicants **must provide a certified copy** of Student Identity documents when applying to enrol your child for Year 7 2022.

The school will not accept your Enrolment Application Form without the following documents.

**Certified Student Identity Documents** (see list: *'Who can certify my documents'*)

**Proof of Address Documents – 100 points required** (see following page)

□ Immunisation History

**History** (only required for students enrolling for the first time in a NSW Government school)

### Student Identity Documents – CERTIFIED COPY of original documents only

#### **Proof of Address Documents**

Parents of all locally residing students seeking enrolment at Chatswood High School, are required to provide Proof of Address documents to the value of **100 points**, as per the *NSW Department of Education 100-point Residential address check.* Please see following page for a list of documents that the school can accept.

#### **General Guidelines:**

- All documents MUST show the full name of the parent and address of the parent or carer with whom the child lives
- All lease agreements **must be valid up to and including July 2022** (Note: if your lease expires before this date, you will need to renegotiate your lease up to and including July 2022)
- All original documents must be certified
- All documents must be current
- Personal references are not considered
